"The Executive Committee discussed the Inspection Report of Dr. Halim Homoeopathic Medical College and Hospital, Laherisarai, Darbhanga, Bihar and it decided to allow admission of students not exceeding 50 (Fifty) only in I-BHMS direct degree course from the session 2001-2002 onwards subject to the conditions that the order of Hon'ble High Court in Patna in C.W.J.C.No. 4343/1993 and 4697/1993 have been implemented and college shall take permission from Central Council before admitting students in II-BHMS Course and also that the University and college shall teach, train and examine strictly as per provisions of Homoeopathy (Degree Course) Regulations, 1983".
